The Zoning Regulation to be excepted is as follows:
Section III - Par. C - Sub-Par. 2. - No building hereinafter
erected, or altered, shall have a less front yard depth than
the average depth of said actual front yard of buildings on
either side.

The reason for exception: In order that an addition
may be erected to an existing dwelling with the required front
yard.
