

PETITION FOR (1) ZONING RECLASSIFICATION
(2) SPECIAL PERMIT

To The Zoning Commissioner of Baltimore County:

I, or we, Frederick C. Eversing, Legal Owners of the property situate on northwest side of Pulaski Highway, at "Golden Ring", in the 18th District of Balto. Co., thence southwest, on said side of "Pulaski Highway, 668' with a right angle depth northwesterly of 150'

hereby petition (1) that the zoning status of the above described property be reclassified, pursuant to the Zoning Law of Baltimore County, from an "A" Residence Zone to an "RM Commercial Zone; and (2) for a Special Permit, under said Zoning Law and Zoning Regulations of Baltimore County, to use the property as hereinafter described, (and improvements now or to be erected thereon), for a

Trailer Camp: Situate on northwest side of Pulaski Highway, beginning 195' southwest of Golden Ring Road, thence southeast, on said side of Pulaski Highway, 970', thence northwest 453', thence northeast 890' to the southwest side of Golden Ring Road, thence southeast on said side of Golden Ring Road, 644' to a point thereon 150' northwest of Pulaski Highway, thence southeast, parallel to Pulaski Highway, 150' and thence southeast, parallel to Golden Ring Road, 150' to beginning. Being property of Fred. C. Eversing, et al. Property to be posted as prescribed by Zoning Regulations.

I, or we, agree to pay expenses of the above reclassification and Special Permit, advertising, posting, etc., upon filing of this petition, and further agree to and are to be bound by the Zoning Regulations and Restrictions of Baltimore County, adopted pursuant to the Zoning Law for Baltimore County.

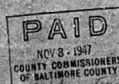

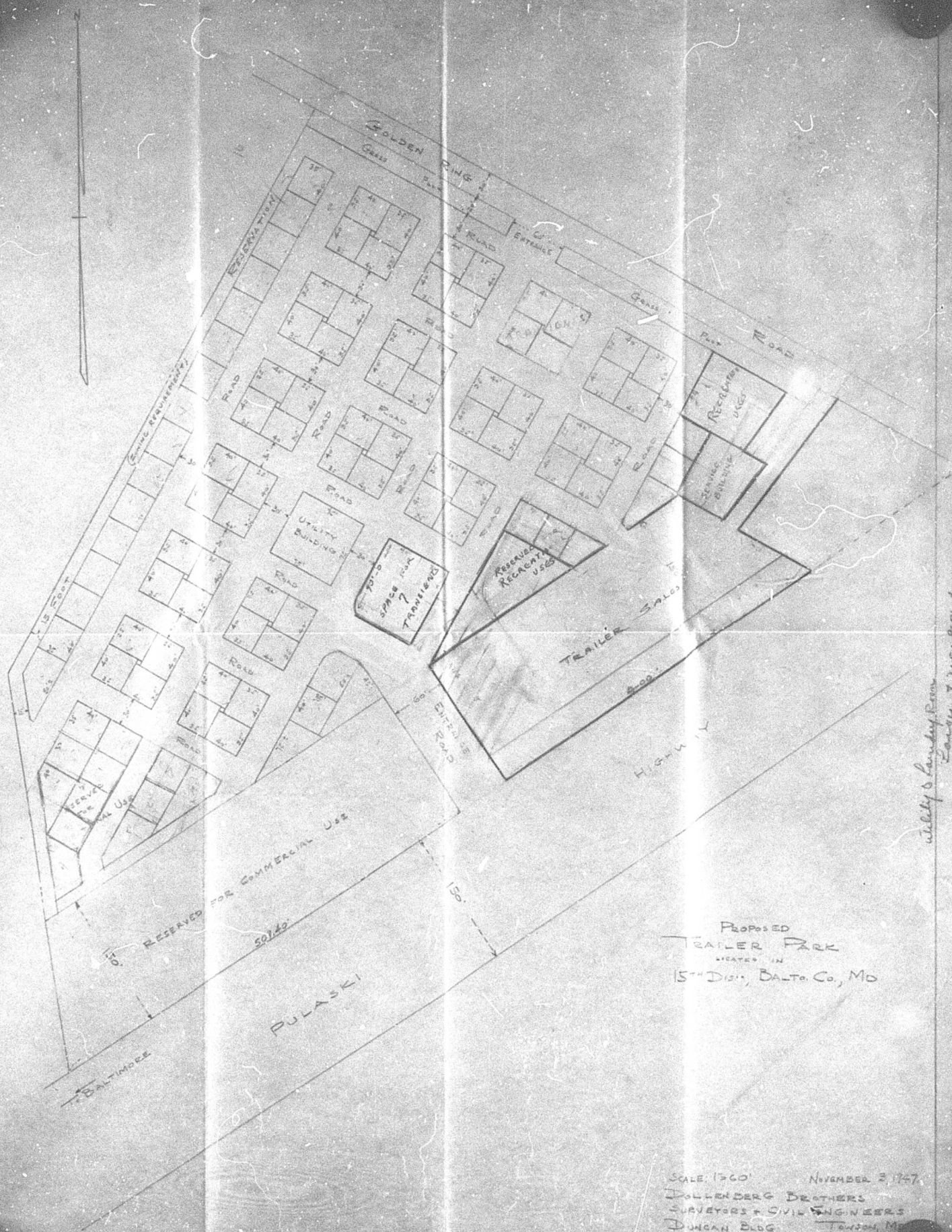
