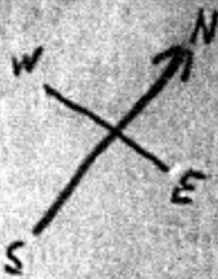


PLAT OF BRIGHTON

MT VERNON AVENUE

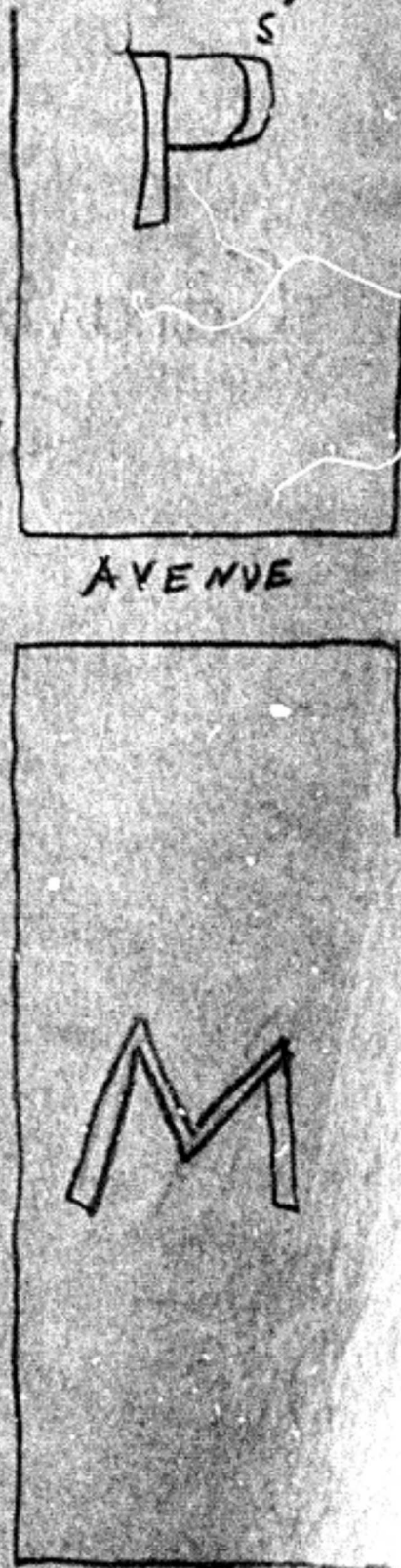
