Your letter of April 28, 2023 to Jeffrey Perlow, Zoning Supervisor has been referred to me for reply. Based upon the information you provided, our review of the Baltimore County Zoning Regulations (BCZR) and Baltimore County's "My Neighborhood" website (County GIS), the following has been determined.

The property known as 7411 Betz Avenue is zoned DR5.5 (Density, Residential – 5.5 Dwelling Units per Acre) and maintains a social (private) club that was approved by Special Permit (Case 1441-S).

The club would now like to expand the building floor area over an existing block foundation that was never built upon nor enclosed. By enclosing the block foundation, there will no decrease in any of the property line setbacks. As such, you requested that the proposed addition over the existing block foundation be considered as within the "spirit and intent" of the referenced Special Permit/Zoning Case.

The Zoning Review Office will consider the proposed addition as being within the spirit and intent of the reference permit/case provided that

no area or parking deficiencies from the requirements of the BCZR are created with the addition.
