Roads Commission.

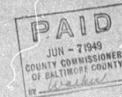

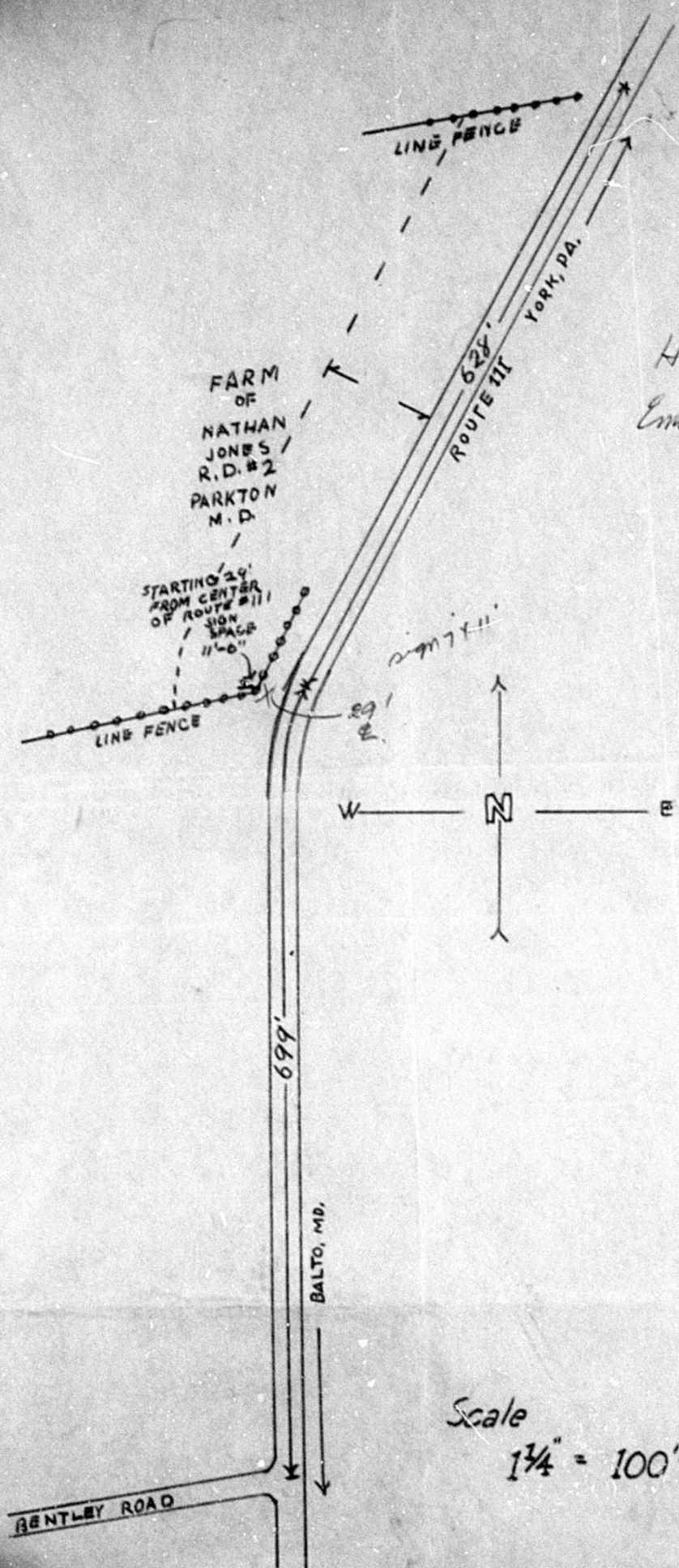

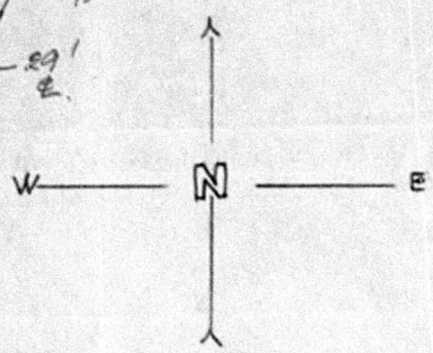
