

RE: PETITION FOR PERMIT FOR TEMPORARY USE OF
PROPERTY - S.J. EDMONDSON AVE. EXTENDED -
2102' WEST ROLLING ROAD - 1ST DISTRICT -
WILLIAM SCHNEIDER, PETITIONER.

The original hearing on the above petition was held on the 11th day of August, 1949 at 9:45 o'clock A.M., and on August 15, 1949, I passed an order denying the permit because the property had not been properly posted due to an incorrect description of the location in the petition whereupon the petitioner applied for a re-hearing on his petition, which was allowed.

The corrected location of the proposed billboard was properly posted on October 3, 1949, giving notice of a hearing to be held on October 13, 1949 at 9:30 o'clock A.M. The hearing attendance, and the location in question being directly opposite an existing commercial area, the proposed sign being small, and will or in any other wise be detrimental to the health, safety, morals and general welfare of the community; therefore, the said Temporary Permit shall be granted.

It is Ordered this 26th day of October, 1949, that the above petition for Temporary Use Permit be and the same is hereby granted for a period of two (2) years from the above date, subject, however, to a setback from the advertising structure of 12 feet from the southernmost side of Edmondson Avenue intended.

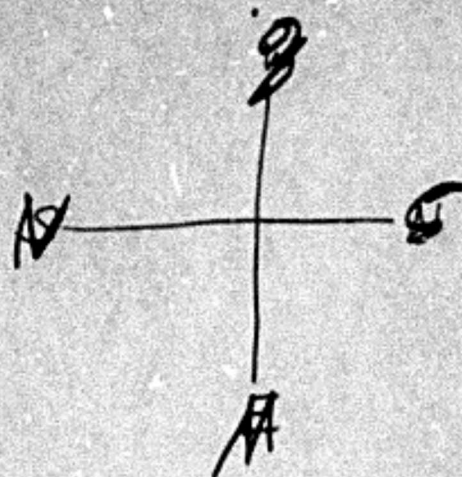

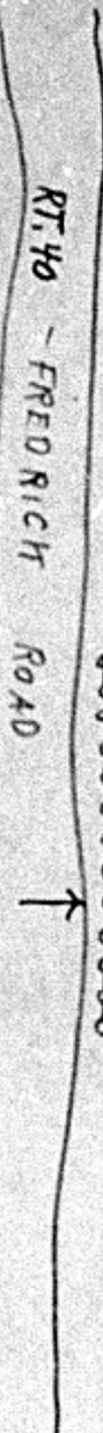
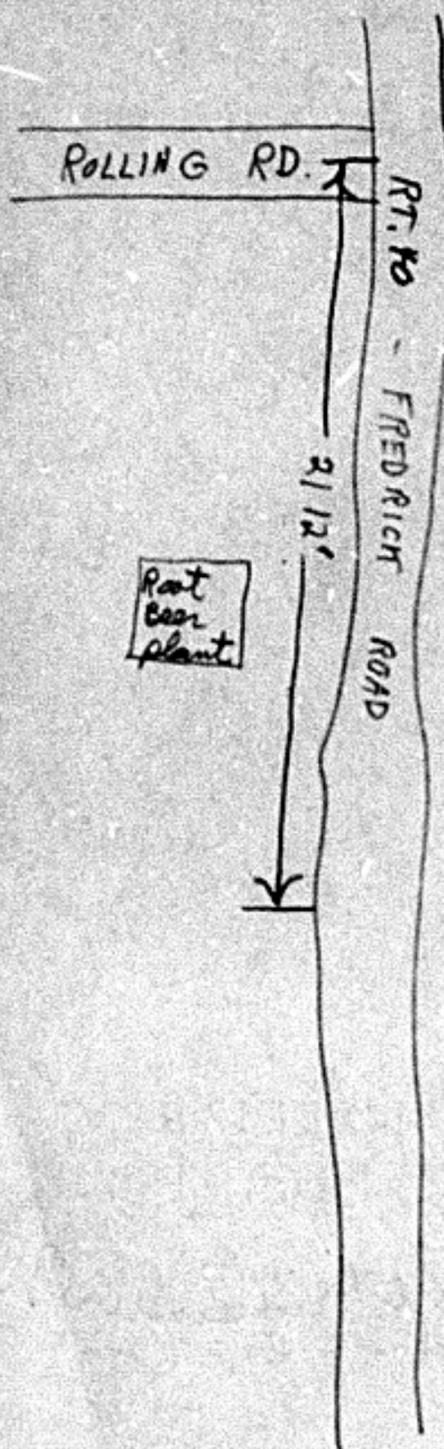
