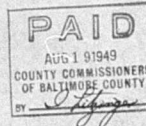
It is this 21st day of October, 1949, ORDERED

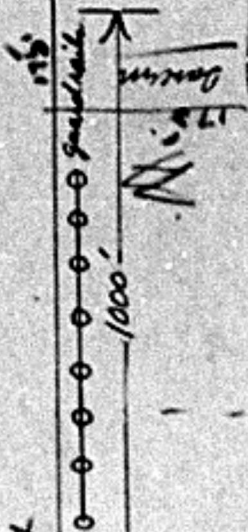
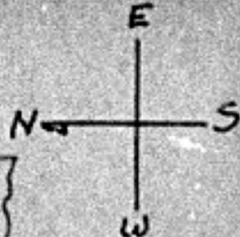
