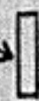

Culvert

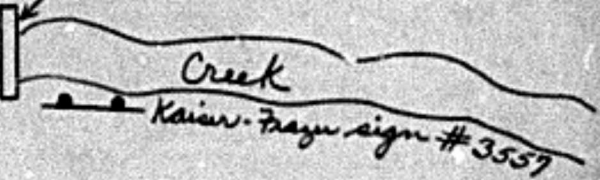


our proposed sign location
