of one advertising structure.

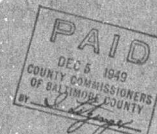

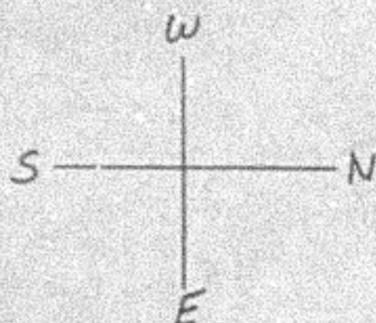
