 (2) years from the above date.

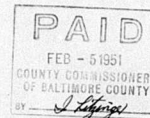

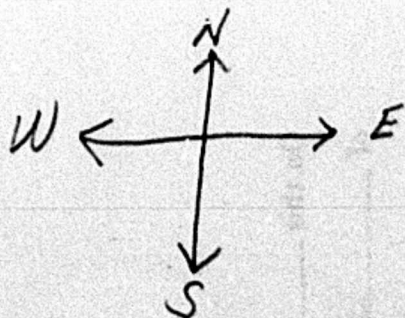

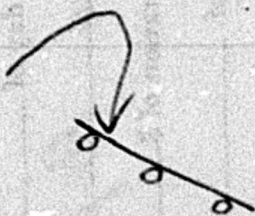
