hereby petition for a Special Permit, under the Zoning Regulations and Restrictions passed by the County Commissioners of Baltimore County, agreeable to Chapter 877 of the Acts of the General Assembly of Maryland of 1943, for a certain permit and use, as provided under said Regulations and Act, as follows:

A Special Permit to use the Land (and improvements now or to be erected thereon) hereinafter described for

DAY NURSERY
South side of Pin Oak Road, 9th District of Balto. Co., beginning 113 feet west of Oak Road, thence westerly on the south side of Pin Oak Road, 18 feet with a rectangular depth southerly of 95 feet. Property known 1709 Pin Oak Road.

The property which is the subject of this petition is located on the south side of Pin Oak Road beginning 113 feet west of Oak Road, in the Ninth District of Baltimore County. Evidence introduced at the hearing was to the effect that day nurseries are needed in this area. Many of the mothers are working and it is necessary that they have some place to leave their children during the day. This type of service is now provided by a Day Nursery located on Joppa Road at Lattasassa Avenue and by a nursery on the north side of White Oak Avenue, 85 feet west of Rock Oak Avenue. The nursery on Joppa Road is over-crowded, approximately 10 children being accommodated at this location. The nursery on White Oak Road is restricted to five children and, therefore, does not do much in the way of satisfying the need for this service in the area.

Even though the lot is small it is not felt that such use, if restricted as to the number of children, would be detrimental to the general welfare of the community. It is the opinion of the Zoning Commissioner of Baltimore County that the special permit for the operation of a private school (Day Nursery) would not be detrimental to the health, safety and general welfare if restricted as aforesaid and the special permit petitioned for should be granted.

It is this 1st day of February, 1952 (WHEREAS by the Zoning Commissioner of Baltimore County that the aforesaid special permit be and the same is hereby granted subject, however, to the number of children using this service being restricted to five exclusive of the children who make their home on the property,

SUBJECT: Day Nursery Inspection made December 5 with Dr. Harry V. Barstow

This home is part of a new house. The children were confined to the first floor at the time of this visit. The living room has a floor space of about 225 square feet. It is attached to a dining room with 120 square feet of floor space.

The kitchen is equipped with a single compartment sink with hot and cold running water. Since the hot water is not high enough in temperature to sterilize the eating utensils, chemical disinfectants are recommended.

The refrigerator is satisfactory.

Mrs. DeWita stated that the children have access to the basement. This room cannot be considered to be kept in a tidy condition. Storm water is said to flood the floor at times. The furnace is exposed and should be protected.

One toilet, located on the second floor, is used by the family and children.

Dear Mrs. DeWita:

Enclosed please find an "Application For License for Maintaining a Day Nursery" to be filled in and returned promptly to the Baltimore County Health Department. I understand you already have a copy of "Law and Regulations Governing Day Nurseries."

Prior to establishment and licensure of a day nursery, it is necessary that the proposed day nursery or nursery school be approved by Baltimore County, County Office Building, Towson 4, Maryland.

It is to be noted that the license fee for each day nursery (nursery school or kindergarten) is two dollars (\$2.00) for each calendar year, and check or money order for this purpose should be made payable to the COUNTY COMMISSIONERS OF BALTIMORE COUNTY.

For further information, you may call Dr. Harry V. Barstow, Director of Division of Child Health Services, who is in charge for us of day nursery licensing in the Baltimore County Health Department.

Dear Mr. Heismuller:

With regard to the application of Mrs. Thelma DeWita, 1709 Pin Oak Avenue, Loth Raven Village, who wishes to establish a day nursery at this property, I wish to advise you that our sanitarian, Mr. F. V. Mangrum, has visited this location and reports that the house is one of a group. The area to be used as a day nursery consists of a living room and a dining room. The limited floor space is large enough to accommodate not more than 5 children, recreational purposes.

If the site of the operation is limited, there is no reason why a day nursery would be objectionable in this neighborhood. It is, of course, anticipated that all requirements of the Plumbing, Fire and Health Departments laws to be met.

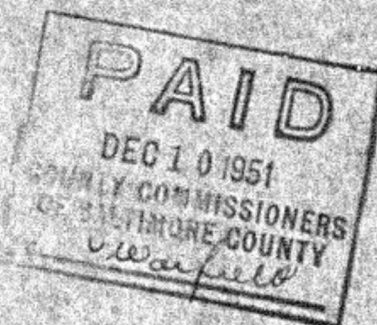

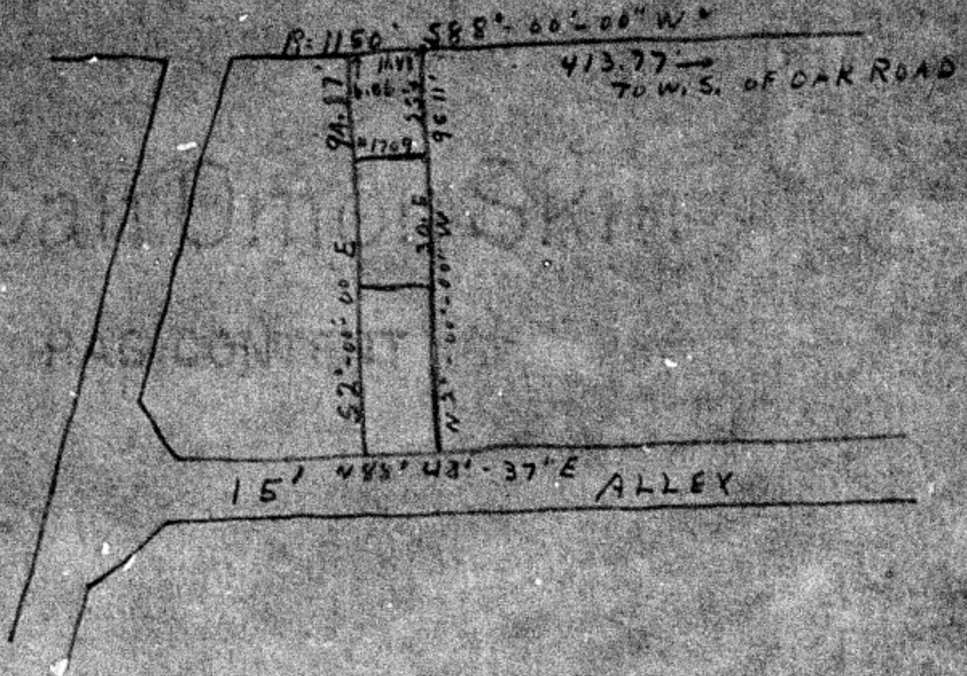
