The property which is the subject of this petition is  
 located on the northeast corner of Yorkway and Weymouth Way, with  
 a frontage on Yorkway of 42 feet and a depth along Weymouth Way of  
 75 feet. The use for which this special permit is requested is for  
 the operation of a Day Nursery.

Evidence produced at the hearing was to the effect that  
 a Day Nursery is needed in this area. Many of the mothers are working  
 and it is necessary that they have a suitable place to leave their  
 children during the day. From information received it is evident that  
 Mrs. Marscheck has had vast experience in this type of work and is  
 well qualified to operate a day nursery.

It is the opinion of the Acting Zoning Commissioner  
 that the special permit for the operation of a private school (day  
 nursery) would not be detrimental to the health, safety and general  
 welfare of the community and the special permit petitioned should be  
 granted.

It is this 17<sup>th</sup> day of November, 1952, ORDERED by  
 the Acting Zoning Commissioner of Baltimore County that the aforesaid  
 special permit and the same is hereby granted, subject, however, to  
 restricting the number of children using this service to ten (10)  
 exclusive of the children who make their home on the property.
