The appeal in the above entitled case is from the Order of the Zoning Commissioner granting a Special Permit allowing commercial raising and housing of turkeys on the petitioner's property, which contains 2.819 acres of land, according to a

Testimony before this Board, shows that the lot in question together with adjoining land, has been used for farming purposes for several generations. Most of the properties in the immediate vicinity are on tracts of land containing several acres and much too large for purely residentail purposes, much of which is used for forming, gardening, poultry and stock raising. The applicants propose to earn their living or the major portion of their living on their said tract of land by means of truck farming and

This Board is of the opinion that they have a right to do this under the Zening Regulations and Restrictions for Baltimore County without the necessity of a Special Fermit from the Zoning Cormissioner, since farming and buildings incidental thereto are allowed under the Zoning Regulations and Restrictions for Baltimore County in an "A" Residential Zone. This Board contends that turkey or poultry raising is an incidental farming use contemplated by the said Zoing Regulations and Restrictions.

The Board therefore agrees with the Zoning Commissioner that turkey raising is a use incidental to the operation of a farm but disagrees with the Zening Commissioner that a Special Permit for said use is required. Therefore the Zoning Commissioner is affirmed in part and is reversed in part.
