to determine whether or not the SPECIAL PERMIT petitioned an interest should be granted, the property in said petition being particularly described as follows:

All that parcel of land in the Ninth District of Baltimore County, Maryland, for the same on the westernmost side of Green Pastures Road, said parcel being: distant 600 feet, more or less, westerly from the center of Joppa Road, running thence and bounding on the westernmost side of said Green Pastures Road North 25 degrees 45 minutes East 150 feet, more or less, thence westerly, parallel to said Joppa Road, 340 feet, more or less, thence northerly, at right angles to the last mentioned line, 125 feet, more or less, thence South 75 degrees 20 minutes West 250 feet, more or less, thence northerly, at right angles to said Joppa Road, 325 feet, more or less, thence North 52 degrees 17 minutes East 100 feet, more or less, thence South 6 degrees 43 minutes East 120 feet, more or less, thence easterly, at right angles to said last mentioned line, 100 feet, more or less, to beginning.
