

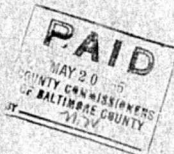

Pursuant to petition filed with  
the Zoning Commissioner of Bal-  
timore County for change or re-  
classification, from an "A" Resi-  
dence Zone to an "E" Commercial  
Zone of the property hereinafter  
described, the Zoning Commissioner  
of Baltimore County by authority  
of the Zoning Act and Regulations  
of Baltimore County, will hold a  
public hearing in the Board Room,  
in the basement of the Reckord  
Building, Towson, Maryland:  
at 2:00 P.M.  
On Monday, March 28, 1955  
to determine whether or not the  
following mentioned and described  
property should be changed or re-  
classified as aforesaid for Appro-  
ved Commercial Use, to wit:  
All that parcel of land in the  
Second District of Baltimore Coun-  
ty, beginning for the same at a  
point on the northeast side of Lib-  
erty Road, said point being situat-  
ed 300 feet, more or less, north-  
westerly from the corner formed  
by the intersection of the northeast  
side of said Liberty Road and the  
northwest side of Washington Ave-  
nue, 50 feet wider, running  
thence easterly on the northeast  
side of said Liberty Road, North 50  
degrees 28 minutes 00 seconds west  
200 feet, more or less to intersect
