. OPINION

The petitioner in this case seeks a special exception for a Day Mursery in an end group home located at the southwest corner of Linden Avenue and Hillen Road. The property, which is could by the petitioner and her parents, faces on Linden Avenue with a side yard along Hillen Read.

It was testified that the house contains three bedrooms on the second floor, three rooms on the first floor, and three rooms in the basement. It is occupied by the petitioner, her child and three receners. Two of the basement rooms are occupied by roomers. It is planned to use the first floor along with a front room of the besement for the Day Mursery. The petitioner stated that she desired to limit the marsery to seven children between the ages of 3 to 5 years; that the hours of operation contemplated are from 8:30 a.m. to 4:30 p.m., Monday through Friday.

The group homes in the area are well maintained, and there are some substantial individual homes to the rear of the property.

The Board is of the opinion that maximum use is already being made of this group home. Its use as a Day Mursery for small children would not be compatible with its present use as a rooming house, and would be detrimental to the general welfare of the neighborhood. The Board feels that the granting of the special exception requested would create a commercial inread in a strictly residential area and thereby tend to lower the value of vicinal properties.
