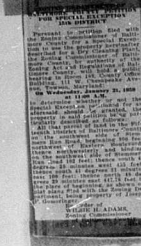

hereby petition for a Special Exception, under the Zoning Regulations and Restrictions passed by the County Commissioners of Baltimore County, agreeable to Chapter 877 of the Acts of the General Assembly of Maryland of 1943, for a certain permit and use, as provided under said Regulations and Act, as follows:

A Special Exception to use the land (and improvements now or to be erected thereon) hereinafter described for:

Dry Cleaning & Store Plant

All that parcel of land in the Fifteenth District of Baltimore County on the Southwest side of Stearns Run Road, beginning 900 feet Northwest of Eastern Boulevard; thence Northwest and blinding on the Southwest side of Stearns Run Road 102 feet; thence South 45 degrees 29 minutes West 455 feet; thence South 41 degrees 31 minutes East 100 feet; thence North 45 degrees 29 minutes East 447.78 feet to the place of beginning.

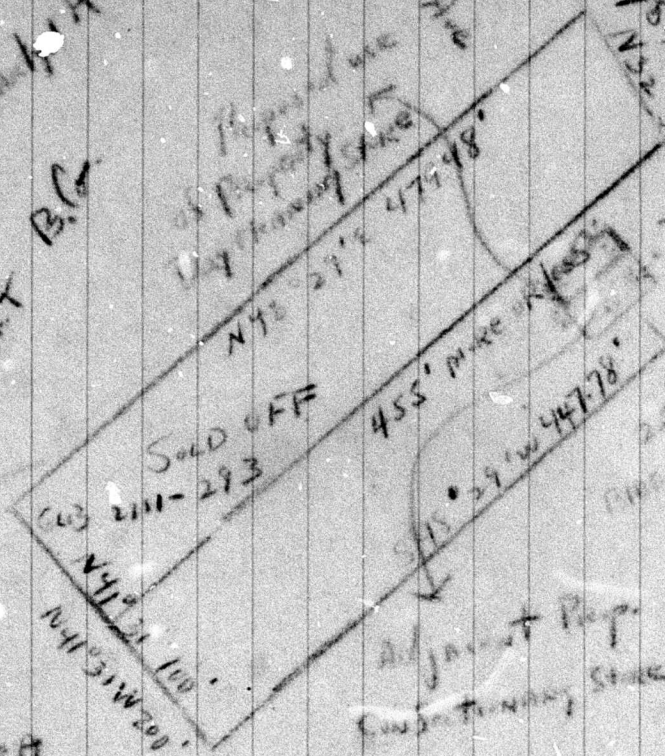
