The applicants, Ed and S. Stanfield and Marjorie R. Stanfield, his wife, are asking whether or not the present Zoning Regulations would permit the operation of a sawmill on their farm at a location more fully set forth in the application. Suffice it to say that the location is some 600 feet north of Old Court Road and the sawaill will be located over a hill that it will not be visible from the road, nor mearby residents. The applicants, themselves, own better than 500 acres of farm land in the immediate vicinity on which there is a substantial amount of timber now growing. The principal attraction to the applicants for the location of the sawmill is that they will use the sawdust and shavings from the operation in their cattle dairy, which is an extremely large one.

The Regulations, themselves, are silent on such an operation. In addition, the sammill operation, insofur as the applicants are concerned, can well be said to be a large part of their farming operations, not only in the cawing of timber but in the projuction of sawdust and shavings, which the testimony shows are useful and valuable on the

The applicants have agreed and it is made a part of this Order that they will not operate the savmill except from 8:00 a.m. to 5.00 n.m.
