The Zoning Regulation to be exempted as follows:

Section 211.3 - Side Yard - Corner lot the building line along the side street shall be not less than 25 feet from the side of lot line and not less than 50 feet from the center line of the side street.

The Reason for the Variance:

To permit a side Street side yard of 11.80 feet instead of required 25 feet or 50 feet from center line.

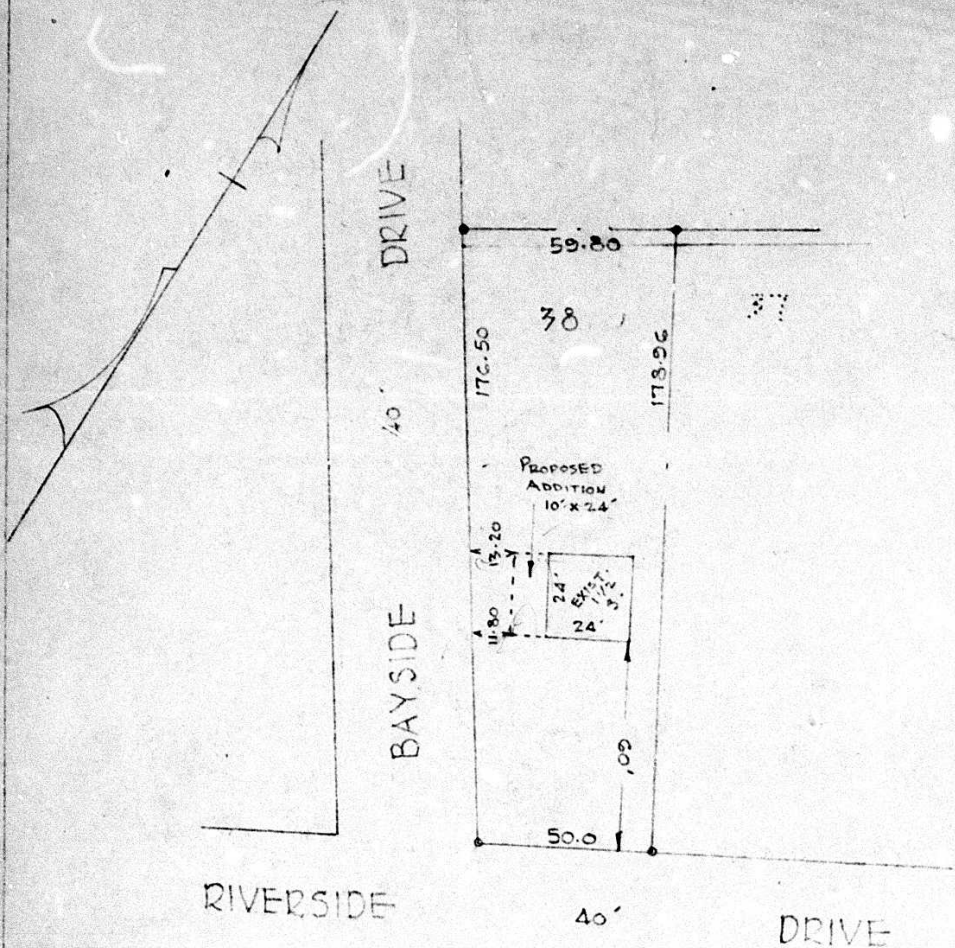
