1. It is our understanding that the proposed commetery is adjacent to the Mourt Carnel Methodist Church site. The Planning staff would consider that the proposed use is appropriate as an adjunct of the church. If granted, the granting should be conditioned upon the establishment of vicening, based forty (Le) Feet from the center along the Mount Carnel Read frontage and thirty (30) feet from the center line of the Protyrboy Wood frontage. The location of the entrance or entrances of the proposed centery also should be subject to approval by the appropriate county agencies.
