## . . . . . . . . . . . . . . OPINION

This is the petition of Leo Goodwin, Jr., et al for a special exception for 1 Painted (Sign) Bulletin to be located on the south side of the Baltimore National Pike, 1906 feet west of Rolling Road in the First District of Baltimore County. The property is zoned "M-L".

The Board heard testimony from Mr. W. R. Walker of the Donnelly Advertising Corporation, that they were leasing from the Gem Stores a small piece of ground on the eastern end of their property fronting on the Baltimore National Pike. It is their intention to build a custom sign, 500 square feet in size. He explained that the word "custom" meant that it would be painted and would be different in the respect from a sign-board that has pasted copy. The zoning regulations of Baltimore County spell out completely the conditions under which such a sign may be erected.

It is the unanimous decision of the Board that the erection of this sign would not in anyway violate Section 502.1 of the Baltimore County Zoning Regulations. Therefore, the special exception is hereby granted.

For the reasons set forth in the aforegoing Opinion, it is this 14 day of February, 1963 by the County Board of Appeals, OR DERED that the special exception petitioned for, be and the same is hereby granted.

Any appeal from this decision must be in accordance with Chapter 1100, subtitle B of Maryland Rules of Procedure, 1961 edition.
