The staff of the Office of Planning and Zoning has reviewed the subject petition for a Special Exception and has the following advisory comments to make with respect to pertinent planning factors:

- 1. The subject property differs from a previous request for a Special Exception for elevator apartments in that six-story buildings now are requested and the density is slightly over twenty-one units per acre. From a planning viewpoint, the difference in density between that permitted per garden apartment and that being sought for elevator apartments is so small as to be inconsequential. Moreover, high-rise development with enclosed parking leaves a greater portion of the site open than would be possible with garden apartment development.
- 2. If granted, the granting should be conditioned upon final approval of site plans by the appropriate County agencies and provision of any necessary widening and improvements thereto for the Roland Avenue extension. Granting should also be conditioned upon provision and improvement of rights-of-way for the possible extension of Stevenson Lane. Granting should be conditioned further upon maintaining the total number of apartments and the building height as shown on the petitioner's site plan.
