For the above reasons the amendment is hereby approved from an order of the County Board of Appeals to permit the operation of a Day Nursery for 26 children instead of 16 children, subject to compliance with the Baltimore County Health Regulations and the Bureau of Fire Prevention pertaining to the operation of a Day Nursery.
