OPINION

This is an application for a special exception for a Nursery School and Day Nursery located in the rear of the property at 8802 Church Lone in the Second District of Baltimore County. The description of the specific property was incorrect as filed with the original petition and has been since corrected with the consent of the Board as attached hereto. Petitioner's Exhibit No. 3, marking the proposed location of the Nursery on a plat, is exactly the same as the amended metes and bounds description. Petitioner's Exhibits No. 1 and No. 2 indicate that the proposed operation has been approved by the Baltimore County Department of Health as to the credentials and preliminary plans of the applicant, and that her application for maintaining a Day Nursery has been approved by the Department of Permits and Licenses of Baltimore County for a maximum enrollment of twenty-three (23) children ranging in ages from two to five years, and to operate from 7:30 a.m. to 6:00 p.m. for five days of each week.

Mrs. McNaney has been operating a Day Nursery on a small scale for some years, and from observing her and hearing all the testimony in the case the Board is convinced that she is eminently qualified to operate the proposed Day Nursery. Further, we find that there will be not only no detriment to the health, safety, and general welfare of the neighborhood, but there is a definite need for an operation of this nature in this vicinity, and that the operation, as a oposed, will meet all the criteria established under Section 502.1 of the Baltimore County Zoning Regulations for a special exception which is allowable, as such, under the present zoning classification of R-10.

Without going into further detail of the evidence before the Board, the Board finds the facts to be as stated above and the petition for a special exception for a Nursery School will, therefore, be granted subject to the approval of the County Department of Health, the Department of Permits and Licenses, and the obtaining of all necessary permits and licenses from any pertinent State or governmental department.
