Beginning for the same at the intersection formed by Westerly right of way line of Wilkens Avenue extended now known as Southwestern Boulevard and the Northernmost side of Tomday Boulevard as shown on the State Roads Commission of Maryland right of way plat number 7161; running thence binding on right of way line of Tomday Boulevard South 58 degrees 28 minutes 13 seconds West 56.72 feet and South 87 degrees 18 minutes 18.12 seconds West 44.02 feet; thence north 10 degrees 25 minutes 40 seconds West 51.27 feet; thence North 1 degree 10 minutes 50 seconds East 77.55 feet; thence south 48 degrees 45 minutes East 132.35 feet to the West side of Southwestern Boulevard as shown on the above mentioned right of way plat; thence binding on the West side of Southwestern Boulevard the following two courses and distances, viz: by a curve to the right having a radius of 3,223.47 feet for a distance of 25.72 feet and South 4 degrees 02 minutes 25 seconds West 96.51 feet to the point of beginning.

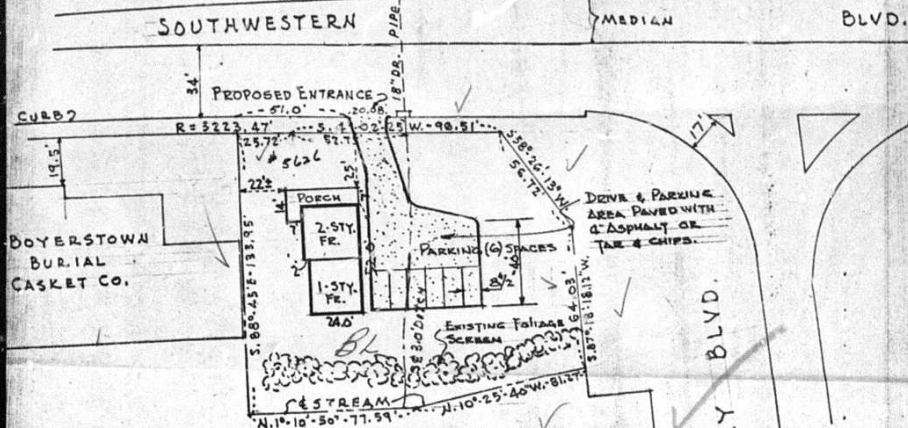
