HEARING: Wednesday, December 13, 1967. (10:00 A.M.)

The staff of the Office of Planning and Zoning has reviewed the subject petition for reclassification from unzoned public land to B.L. zoning. It has the following advisory comments to make with respect to pertinent planning factors:

1. The planning staff is shocked to find that the subject property is not in public ownership. Although the optimal use of this property would be a public one, we recognize that, in private ownership, the property must be zoned for some reasonable use.
2. From a planning viewpoint that zone which best typifies the existing uses in this block in relationship to the center as a whole would be the apartment zone. Offices would be permitted by Special Exception; outright commercial uses would and should be prohibited.

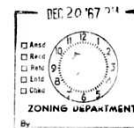

SUBJECT: Reclassification from Public Land to B.L. for the Baltimore Transit Co. located NE corner of Dundalk Avenue and Center Place 12th District (Item 12, November 7, 1967)

Dear Sirs:

The Zoning Advisory Committee has reviewed the subject petition and has the following comments to offer:

BUREAU OF ENGINEERING:
Water - Existing 6" water in Dundalk Avenue
Adequacy of existing utilities to be determined by developer or his engineer.
Sewer - Existing 6" sanitary sewer in Center Place.
Road - Center Place is to be developed as a minimum 30' road on a 40' P/W.

TRAFFIC ENGINEERING:
If this land is developed as B.L. land, it will generate approximately 300 trips per day. However, if the petition was changed to request an R.A. with a Special Exception for offices, this site could be expected to generate only 150 vehicles per day.

HEALTH DEPT.:
Since public water and sewer are available to the subject site, this office has no comment.

STATE ROAD COMMISSION:
There are no State roads involved; therefore, this office has no comment.

FIRE BUREAU:
Petition will be required to meet all Fire Dept. regulations for an office building.

ZONING ADMINISTRATION DIVISION:
If the petition is granted, no occupancy may be made until such time as plans have been submitted and approved and the property inspected for compliance to the approved plan.
The above comments are not intended to indicate the appropriateness of the zoning action requested, but to assure that all parties are made aware of plans or problems that may have a bearing on this case. The Director and/or the Deputy Director of the Office of Planning and Zoning will submit recommendations on the appropriateness of the requested zoning 10 days before the Zoning Commissioner's hearing.

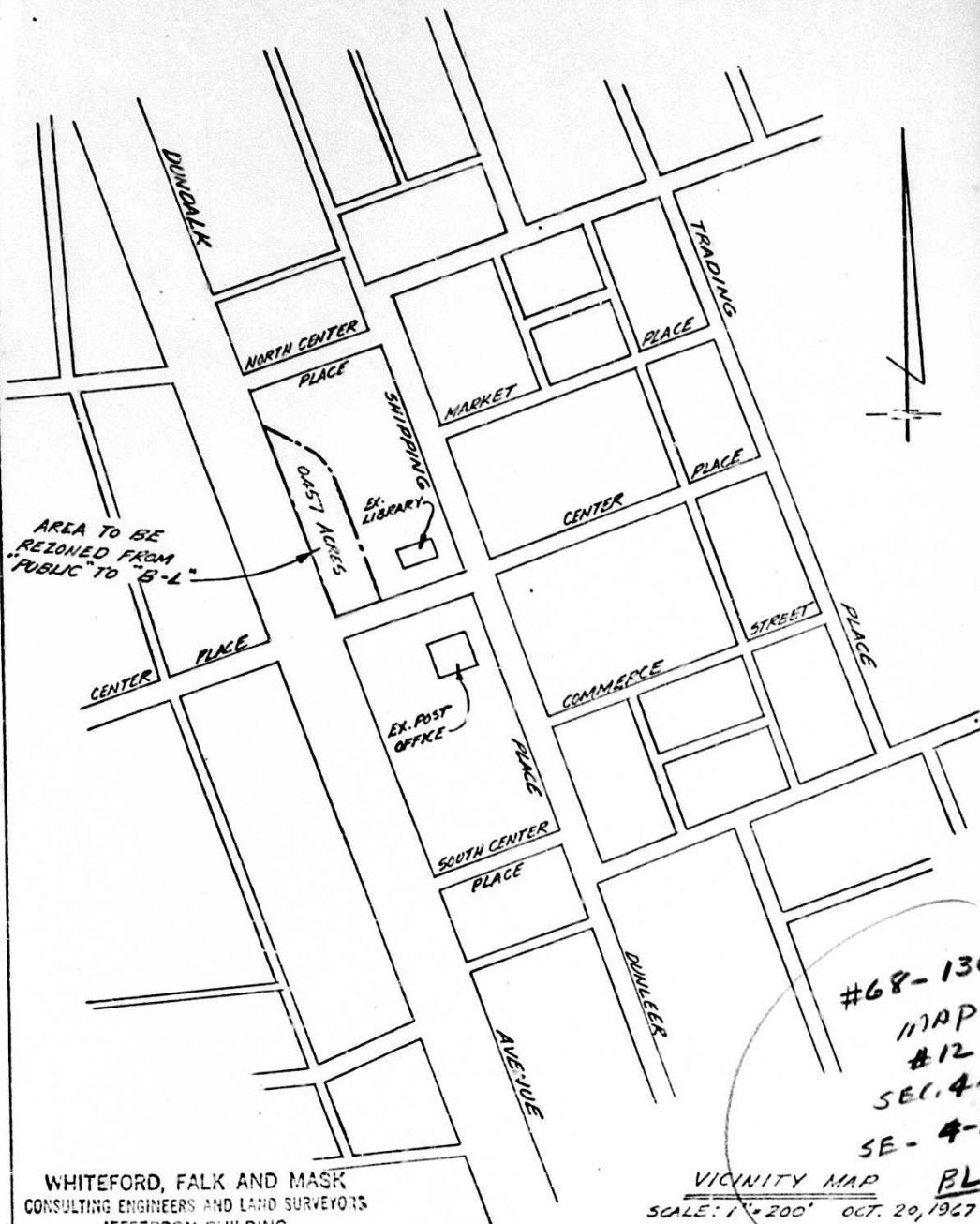
