Dear Sirs:

The Zoning Advisory Committee has reviewed the subject petition and has the following comments to offer:

BUREAU OF ENGINEERING:
Minor and sanitary sewer are under construction as shown on the submitted plan. The proposed roads shown will be constructed in the near future.

STATE ROADS COMMISSION:
The E/W line on the Northwest Expressway is as is indicated on the petitioner's plot plan.

FIRE PREVENTION:
The petitioner will be required to meet all Fire Dept. regulations as to apartment developments.

PROJECT PLANNING DIVISION:
The tentatively approved preliminary plan for Westbury shown Caraway Road going through the subject tract along the same alignment as the 30 ft. private drive. In the event that the petition is granted, this plan should be followed - for if the apartments are an afterthought, the need for the road as planned should be as great as the increased density.

ZONING ADMINISTRATION DIVISION:
If the petition is granted, no occupancy may be made until such time as plans have been submitted and approved and the property inspected for compliance to the approved plan.

WATER DEPARTMENT:
Since public water and sewers are proposed this office has no comments.

The above comments are not intended to indicate the appropriateness of the zoning action requested, but to assure that all parties are made aware of plans or problems that may have a bearing on this case. The Director and/or the Deputy Director of the Office of Planning and Zoning will submit recommendations on the appropriateness of the requested zoning 10 days before the zoning Commission's hearing.

The Petitioner seeks a reclassification of his property, consisting of 21.8 acres of land, from an R-6 zone to an RA zone. Plans call for the construction of 341 apartment units, 45% of which will be of the one bedroom type, 40% of which will be of the two bedroom type, and 15% of which will be of the three bedroom type. The proposed apartments will be of brick construction and will complement an existing apartment development also owned by the Petitioner.

The proposed development will be bordered on the west by the proposed Northwest Expressway. Water and sewer facilities are available and adequate to service the proposed units. There was evidence of numerous zoning changes in the area. No one appeared in protest.

For the foregoing reasons, IT IS ORDERED by the Deputy Zoning Commissioner of Baltimore County, this 3 day of July, 1968, that the herein described property or area should be and the same is hereby reclassified from an R-6 zone to an RA zone from and after the date of this Order, subject to approval of the site plan by the State Roads Commission, the Bureau of Public Services and the Office of Planning and Zoning.
