Requests by your constituents that you interceds for them in soning matters while the suning commissioner or the board of appeals call for the application of section 310 of the Baltimore County Charter. The second sentence of that section reads as follows:

"Except through legislation duly enacted, neither the county council nor any member thereof shall, either directly or indirectly, give orders he any officer, agent or employee of the executive branch of the county government, nor shall they in any manner attempt to influence or coarse any such officer, agent or employee in the performance of his duties." (Emphasis supplied.)

The soning commissioner is an officer in the "Office of Planning and Zaming", which is one of the six offices in the administrative services constituting the executive branch of the county government. Accordingly, it would seem impossible for you to intercede for constitueous with the soning commissioner locause of section 310 of the Charter, quoted above. In other words, your hands are tied by the provisions of the Charter with respect to the soning commissioner.

It would be equally unproper to intereede for a constituent before the county beard of appeals in soming matters, but for another reason. The board of appeals in not a part of the executive branch of the control government; on the contrary, it is a part of the judicial branch and is created by a separate article of the Charier, namely, Article VI. The board's function are is their matuse judicial. They are to make functions of fact and they must apply to those facts reless of law, and they must amounce the results of their findings and decisions. The county is in no sense a party to the proceedings before the board, and this includes the executive and the members of the cancil. It is improper for members of the executive and legislative branches of the county of the board at appeals in soming matters.
