

Although it appears the matter will now proceed to hearing, I felt that I should respond to certain points in your letter. First, it is not my client's present position that the gatehouse is an accessory structure. Rather, as I stated in my letter of December 2, 1983 to you, his position is that the gatehouse is not substantial enough to qualify as an accessory structure. cifies that accessory uses or structures are a permitted use in a BL zone. This would appear to be contrary to your letter of December 12. I have also enclosed a County Zoning Map with this letter, which illustrates that the BL-CCC zone which envelops the property is bounded on two sides by a DR2 zone. Under Baltimore County Zoning Regulation 230.1, any use permitted in an adjoining residential zone would be permitted in the BL zone. 


