Highways:

Carroll Mill Road, an existing public road, is proposed to be further improved in the future on a 60-foot right-of-way.

The entrance locations are subject to approval by the Department of Traffic Engineering, and shall be constructed in accordance with Baltimore County Standards and Specifications.

Storm Drains:

Provisions for accommodating storm water or drainage have not been indicated.

A tributary to Carroll Branch traverses this property. Therefore, a 100-year flood plain, plus 1 foot of freeboard, will be required prior to building permit

Development of this property through stripping, grading and stabilization could result in a sediment pollution problem, damaging private and public holdings downstream of the property. A grading permit is, therefore, necessary for all grading, including the stripping of top soil.

The Petitioner must provide necessary drainage facilities (temporary or permanent) to prevent creating any nuisances or damages to adjacent properties, especially by the concentration of surface waters. Correction of any problem which may result, due to improper grading or improper installation of drainage facilities, would be the full responsibility of the Petitioner.



Baltimore County Department of Health. During the summer, a day camp for 60 children, ages 2 to 10, would provide a planned program and activities related to arts, crafts, nature, games, play, etc. with day care provided before and after the programmed day. The comprehensive for twelve months would be \$3,380.00 per child.

Testimony by the Protestants indicated that access roads, both Carroll Mill and Stockton, are dangerously curved and narrow, in fact, they asserted that Carroll Mill Road was only 10 to 12 feet wide and that the additional traffic caused by the delivery and pick-up of 60 children during morning and evening hours would affect the safety of local children and pets, as well as persons travelling these roads in vehicles. They indicated that a business grossing over \$200,000 per year would be incompatible with the existing agricultural and residential uses in the neighborhood and that such a school and children's care facility is not needed in the area. In addition, any school or children's care facility for over 6 children would adversely affect the neighborhood.

All parties to the hearing stipulated that the Deputy Zoning Commissioner could visit the site and the general neighborhood.

After due consideration of the testimony and evidence presented, as well as a field inspection of the property, in the opinion of the Deputy Zoning Commissioner, the requirements of Section 502.1 and 1A01.2.C have been met and the special exception for a nursery school, kindergarten and Samp should be granted and the special exception for a day care center should be held sub curia until such time as the Counsel for the Petitioner redusts that the hearing on that portion of the petition be continued.
