FINDINGS OF FACT AND CONCLUSIONS OF LAW

The Petitioners herein request a variance to permit an accessory structure (garage) to be set back zero feet from the side property line instead of the required 2 1/2 feet.

The Petitioners appeared and testified. Roseann Collins appeared and testified as a Protestant and represented three other Protestants.

At the onset of the hearing, the Petitioners moved to amend the Petition to request a setback of one foot, as more particularly shown on Petitioners' Exhibit 1.

Testimony indicated that the subject property, zoned D.R.5.5, measures 60' x 115' and is improved with a two-story dwelling which faces Holly Circle. The Petitioners constructed a 12' x 28' garage on the south side of their property, but after a complaint was filed by the adjoining property owner, it was discovered that the contractor had constructed the garage only one foot from the property line. The Petitioners testified that the adjoining property owner to the south who had originally complained, was not opposed to the requested variance.

The Protestants are concerned that if the variance were granted, other homeowners will construct accessory structures on, or close to, their property lines. The Petitioners seek relief from Section 400.1, pursuant to Section 307, Baltimore County Zoning Regulations (BCZR).

An area variance may be granted where strict application of the zoning regulation would cause practical difficulty to the petitioner and his property. McLean v. Soley, 270 Md. 208 (1973). To prove practical difficulty for an area variance, the petitioner must meet the following:

- whether strict compliance with requirement would unreasonably prevent the use of the property for a permitted purpose or render conformance unnecessarily burdensome;
- whether the grant would do substantial injustice to applicant as well as other property owners in the district or whether a lesser relaxation than that applied for would give substantial relief; and
- whether relief can be granted in such fashion that the spirit of the ordinance will be observed and public safety and welfare secured.

Anderson v. Bd. of Appeals, Town of Chesapeake Beach, 22 Md. App. 28 (1974).

It is clear from the testimony that if the variance were granted, such use as proposed would not be contrary to the spirit of the BCZR and would not result in substantial detriment to the public good.

After due consideration of the testimony and evidence presented, it is clear that a practical difficulty or unreasonable hardship would result if the instant variance were not granted. It has been established that the requirement from which the Petitioners seek relief would unduly restrict the use of the land due to the special conditions unique to this particular parcel. In addition, the variance requested will not be detrimental to the public health, safety, and general welfare.

Pursuant to the advertisement, posting of the property, and public hearing on this Petition held, and for the reasons given above, the requested variance should be granted.

Therefore, IT IS ORDERED by the Zoning Commissioner of Baltimore County, this _____ day of September, 1985, that the Petition for Zoning Variance to permit an accessory structure (garage) to be set back one foot from the side

property line instead of the required 2 1/2 feet be and is hereby GRANTED, from and after the date of this Order, subject to the following:

- The Petitioners may apply for their building permit and be granted same upon receipt of this Order; however, Petitioners are hereby made aware that proceeding at this time is at their own risk until such time as the applicable appellate process from this Order has expired. If, for whatever reason, this Order is reversed, the Petitioners would be required to return, and be responsible for returning, said property to its original condition.
