FINDINGS OF LACT AND CONCLUSIONS OF LAW

The Petitioner herein requests a Special Hearing to approve an amendment of the Zoning Plat previously filed in Zoning case #89-362-XA so as to provide for the subdivision of the subject property into three (3) parcels and to substitute a car wash facility for the retail strip shown on the original plat; a Special Exception, pursuant to Section 236.4 to permit a car wash in a B.R. zone; and a variance of Section 238.2 to permit front, back and side yard setbacks regarding the Glass Installer/Lube & Tune Building and the Ministorage Building A, as more particularly described in Petitioner's Exhibit 1.

Mr. Richard Israel, on behalf of the Petitioner, appeared, testified and was represented by E. Harrison Stone, Esquire. Also appearing on behalf of the Petitioner was Anthony J. Corteal, a Professional Engineer, and Ollie K. Mumpower, Jr., a Traffic Engineer. There were no Protestants.

Testimony indicated that the subject property, located at the intersection of North Point Boulevard and Merritt Boulevard is zoned B.R. and consists of approximately 5 acres +/-. The proposed retail strip which incorporated a bank was approved and authorized, pursuant to Zoning

case 89-362-XA. The Petitioner now desires to replace the retail strip with the aforementioned car wash and automotive uses..

Mr. Corteal testified that ingress and egress to the proposed car wash will be on Old North Point Road and that a minimum of 26 stacking spaces will be maintained. He testified that, in his op_nion, the conditions delineated in Section 502.1 of the Baltimore County Zoning Regulations (B.C.Z.R.) are satisfied. The site plan provides adequate parking and stacking space for the proposed use. The Petitioner testified that landscaping will comply with the Baltimore County Landscaping Manual.

Mr. Mumpower testified that replacement of the retail strip with the proposed car wash and automotive facilities will greatly reduce the projected traffic congestion due to the resulting decrease in the number of merchants on the subject site.

It is clear that Section 236.4 of the B.C.Z.R. permit the use requested by the Petitioner in a B.R. zone by special exception. It is equally clear that the proposed use would not be detrimental to the primary uses in the vicinity. Therefore, it must be determined whether the conditions as delineated in Section 502.1 are satisfied by the

The Petitioner had the burden of adducing testimony and evidence which would show that the proposed use met the prescribed standards and requirements set forth in Section 502.1. In fact, the Petitioner has shown that the proposed use would be conducted without real detriment to the neighborhood and would not adversely affect the public interest. The facts and circumstances do not show that the proposed use at the particular location described by Petitioner's Exhibit 1 would have any adverse impact above and beyond that inherently associated with such a special exception use, irrespective of its location within the zone. Schultz v. Pritts, 432 A2d 1319 (1981).

The proposed use will not be detrimental to the health, safety or general welfare of the locality, nor tend to create congestion in roads, streets, or alleys therein, nor be inconsistent with the purposes of the property's zoning classification, nor in any other way be inconsistent with the spirit and intent of the B.C.Z.R.

After reviewing all of the testimony and evidence presented, it appears that the special exception should be granted, with certain restrictions as more fully described below.

An area variance may be granted where strict application of the zoning regulations would cause practical difficulty to the Petitioner and his property. McLean v. Soley, 270 Md. 208 (1973).

Mr. Corteal testified that in view of the topography of the subject property, the applicable setback requirements create a practical difficulty which will greatly inhibit and restrict the Petitioner's development of the subject site.

It is clear from the testimony that if the variances were granted, such use as proposed would not be contrary to the spirit of the B.C.Z.R. and would not result in substantial detriment to the public good.

After due consideration of the testimony and evidence presented, it is clear that a practical difficulty or unreasonable hardship would result if the variances were not granted. It has been established that the requirements from which the Petitioner seeks relief would unduly restrict the use of the land due to the special conditions unique to this particular parcel. In addition, the variance requested will not be detrimental to the public health, safety and general welfare.

Pursuant to the advertisement, posting of the property and public hearing on these Petitions held, and for the reasons give above, the relief requested should be granted.

THEREFORE, IT IS ORDERED by the Zoning Commissioner of Baltimore County this of day of /..., 1989, that the Petition for Zoning Variance from Section 238.2 for a 17 feet rear setback in lieu of the required 30 feet; a 38 fest front setback in lieu of the required 50 feet; a 25 foot side setback in lieu of the required 30 feet and 20 feet side setback in lieu of the required 30 feet for the Glass Installer/Lube and Tune Building; and a variance from Section 238.2 for a 1 foot setback in lieu of the required 30 feet for the Ministorage Building, all lb accordance with Petitioner's Exhibit 1, be and is hereby GRANTED; and

IT IS FURTHER ORDERED that the Petition for Special Exception for a car wash in a B.R. zone, pursuant to Section 236.4, and in accordance with Petitioner's Exhibit 1, be and is hereby GRANTED; and

IT IS FURTHER ORDERED that the Petition for Special Fearing to amend the zoning plat and relief granted in case #89-362-XA to provide for the subdivision of the subject property into three (3) parcers and to substitute a car wash and automotive facility for the approved retail strip, as more fully described on Petitioner's Exhibit 1, is hereby GRANTED subject, however, to the following restrictions which are conditions precedent to the relief granted merein:

> 1. The Petitioner may apply for his building that proceeding at this time is at his own risk until such time as the 30 day appellate process from this Order has expired. If, for whatever reason, this Order is reversed, the Petitioner would be required to return, and be responsible for returning, said property to its original

2. Compliance with the comments submitted by the Baltimore County Zoning Plans Advisory Committee (ZAC), which are adopted in their entirety and made a part of this Order.

All parking lot lighting shall be no more than 20 feet above ground. All exterior lighting shall be directed downward and shall not diffuse onto any residential property.

Reference is made to the enclosed letter from STV/Lyon to Commissioner Haines dated November 27, 1989. As such letter indicates, we are hopeful that the Zoning Commissioner will approve our revised CRG Plan, as being within the spirit and intent of his previous Order in the case dated June 23, 1989. My understanding is that the current delay in granting such approval, stems from concern over our reduction of the rear setback from 49 feet to 44.8 feet.

As your file will indicate, the Plan approved at the hearing, at which there were no protestants, provided for a 24 foot distance from the rear of the mini-warehouse building to the curb line; and then 25 feet from the latter to the property line. The revised CRG Plan shortens the former from 24 feet to 19.8 feet, but retains the same distance from the curb line to the property line. It is important to emphasize here that even after such reduction, the remaining 44.8 foot distance is still well in excess of the required 30 feet; and further, that the conceptual landscape plan approved by the Planning Office, provides for the installation of chain link fencing at the top of the slope between the properties, with planting on both sides.

We are hopeful that with this clarification, our revised CRG Plan will now be approved.
