FINDINGS OF FACT AND CONCLUSIONS OF LAW

The subject property and requested relief are more particularly described on Petitioners' Exhibit No. 1, the plat to accompany the Petition for Administrative Variance.

The Petitioners having filed a Petition for Administrative Variance and the subject property having been posted, and there being no request for a public hearing, a decision shall be rendered based upon the documentation presented.

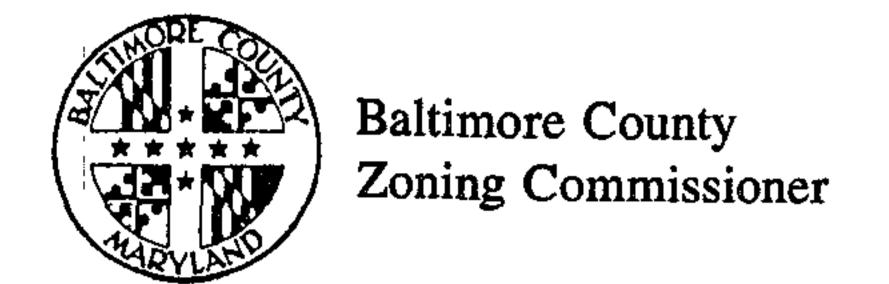

3. When applying for a building permit, the site plan filed must reference this case and set forth and address the restrictions of this Order.
