



I, Margaret A. Swiss, know definitely that a used car lot has been located at 527 Eastern Avenue since 1948. I personally lived at 529 Eastern Avenue from 1946 to June of 1957.

In 1948, George Norris rented the car lot from my father, Joseph J. Banz, who in turn sold it to Thomas Buehler, who in turn sold it to H & K Motors, who in turn sold it to Little Richards, who it turn sold it to S & S Auto Sales, who in turn sold it to Dick Rich Used Cars, who in turn sold it to Jim's Auto Sales, who in turn sold it to Bunky Matthew.

My sister, Mrs. Philip Green and I inherited the property at 527-529 Eastern Avenue in 1964 and there has been a used car lot located there up until the time we sold it in 1973 to Mr. & Mrs. Clarence Cox. Operations of a used car lot continued up until the middle of 1976.
