## Signage Lease Agreement

Back River United Methodist Church hereby agrees to lease to Ryan Homes a portion of their property located on 544 Back River Neck Road Baltimore, MD as outlined below:

- 1. The initial term of this Agreement shall be for a period of twelve (12) months, and is for the purpose of installing a "road sign" along the Back River Neck on the Property. The initial term of this Agreement shall commence on the date the sign is installed on the Property.
- 2. The sign will be constructed and installed at the location designated by Ryan Homes and shall be removed upon completion of this Agreement at the sole expense of Ryan Homes.
- 3. The terms of this lease shall be subject to any permit requirements, received written requests, or warnings to remove the sign by the County. In the event that the County requires removal of the sign, it will be done at the sole expense of Ryan Homes and the Agreement shall terminate. In the event that the County requires a permit for the sign, such permit will be obtained by Ryan Homes at its sole expense.
- 4. Ryan Homes shall be solely responsible for any fines that may be levied by the County for placement of the sign.
- 5. Ryan Homes shall be responsible or have any liability for any acts of vandalism or destruction by others.
- 6. The monthly lease rate shall be in the amount of \$500 per month for the initial lease term, paid on a monthly basis due by the 1<sup>st</sup> of the each month following the date of sign installation.
