AMENDED ORDER ON MOTION FOR RECONSIDERATION

This matter comes before the Office of Administrative Hearings ("OAH") for reconsideration of the Opinion and Order entered on the 13th of April, 2021 in the above-captioned case, which considered Petitions for Special Hearing and Variance filed on behalf of Yahrzeit Memorials, Inc. ("Petitioner"). The Special Hearing was filed under § 500.7 of the Baltimore County Zoning Regulations ("BCZR") to approve the setback from the northeast corner of the proposed addition to Reisterstown Road is a side yard, not a front yard, therefore no Variance is required. A Petition for Variance was filed to permit 7 parking spaces in lieu of the required 14 parking spaces. To permit a front yard setback of 16 ft. in lieu of the required 25.3 ft.

Due to the COVID-19 pandemic, a public WebEx hearing was conducted virtually in lieu of an in-person hearing. The Petition was properly advertised and posted.

Substantive Zoning Advisory Committee ("ZAC") comments were received from the Department of Planning ("DOP"). They did not oppose the requested relief, subject to proposed conditions. As will be explained below, these conditions are no longer relevant.

Petitioner Steve Venick appeared in support of the requested relief. Drew Robinson and Arnold Jablon, Esq. represented the Petitioner. Brian Dietz of Dietz Surveying, Co. the engineer who prepared and sealed the site plan also appeared. John Gontrum, Esq. appeared on behalf of

Asheville Partners LLC, the owners of the adjacent Colonial Plaza Shopping Center. There were no protestants or interested persons in attendance. However, Mr. Robinson submitted e-mail correspondence between Mr. Venick and Ms. Kristin Zeminski of the Colonial Village Pikesville Community Association stating the association's support for the project. (Petitioner's Exhibit 11). Mr. Robinson also explained that after the original Petition was filed Mr. Gontrum entered his appearance and counsel requested a postponement of the hearing in order to attempt to negotiate a modification of the site plan. As a result of those negotiations the proposed office space addition was moved from the southeast corner of the lot to the northwest corner. The redlined site plan was admitted as Petitioner's Exhibit 9. Mr. Robinson further explained that based on this modification the petitioner no longer needs the special hearing or front yard setback relief. As a result, the only remaining relief sought at the hearing was the variance from BCZR Sec. 409.6 to allow 7 parking spaces in lieu of the required 14 spaces. Mr. Gontrum confirmed the accuracy of Mr. Robinson's proffer.

Variance

A variance request involves a two-step process, summarized as follows:

- (1) It must be shown the property is unique in a manner which makes it unlike surrounding properties, and that uniqueness or peculiarity must necessitate variance relief; and
- (2) If variance relief is denied, Petitioner will experience a practical difficulty or hardship.

Cromwell v. Ward, 102 Md. App. 691 (1995).

As Mr. Robinson explained, the property is unique in several respects. It is approximately a third of an acre. It is an irregular triangular shape and is bordered by two public roads. The existing structure is a former gas station that is set in the far back of the site. The two access points on Reisterstown road eat up much of the potential area for parking spaces. Mr. Venick testified

that his family has operated Fram Monuments at this location for over 40 years. He explained that it is not a typical retail business in that most of their business is conducted on-line or over the phone. There are few "walk in" customers so the 7 existing parking spaces have proven to be more than adequate. He further explained that the proposed addition will simply expand the office space for the business and should not generate any additional need for parking. Finally, Mr. Venick noted that he owns the adjoining properties on Colonial Road that will back to the proposed office addition.

I therefore find that the subject property is unique and that if the parking variance is denied the petitioner would suffer practical difficulty and hardship because they would be unable to construct the office space they need. I further find that the variance relief is within the spirit and intent of the BCZR and that it will not harm the public health, safety, and welfare. This finding is buttressed by the lack of community opposition or any county agency opposition.

THEREFORE, IT IS ORDERED this <u>26th</u> day of April 2021, by this Administrative Law Judge, that the Petition for Special Hearing under BCZR § 500.7 to confirm that the setback from the northeast corner of the proposed addition to Reisterstown Road is a side yard, not a front yard, and that therefore no Variance is required be and is hereby DISMISSED WITHOUT PREJUDICE, as MOOT; and,

IT IS FURTHER ORDERED that the variance to permit a front yard setback of 16 ft. in lieu of the required 23 ft. is hereby DISMISSED WITHOUT PREJUDICE, as MOOT; and,

IT IS FURTHER ORDERED that the variance from BCZR § 409.6 to permit 7 parking spaces in lieu of the required 14 parking spaces is hereby GRANTED.

The relief granted herein shall be subject to the following:

 Petitioner may apply for necessary permits and/or licenses upon receipt of this Order. However, Petitioner is hereby made aware that proceeding at this time is at their own risk until 30 days from the date hereof, during which time an appeal can be filed by any party. If for whatever reason this Order is reversed, Petitioner would be required to return the subject property to its original condition.

 Petitioner shall not plant any landscaping, or allow any existing landscaping to grow above the existing fence between Petitioner's and Asheville Partner's adjoining property.

Any appeal of this decision must be made within thirty (30) days of the date of this Order.

The Petitioner's property is located at the corner of Reisterstown Road and Colonial Road, at 7020 Reisterstown Road. The property consists of a one-story building, originally constructed in or about 1951. There has never been any addition or modification to the existing building. The property is principally zoned BL with a strip of DR 5.5 to the west property line, adjacent to residential properties facing Alden Road, which is perpendicular to Colonial Road. Petitioner's business is retail, providing graveside markers and monuments. The existing business has been located at this site for approximately 30 years. The Petitioner purchased the property and the business in or about 2005. The front of the property faces Reisterstown Road and Colonial Road. The northeast property line is to Reisterstown Road and with Colonial Plaza Shopping Center (hereinafter referred to as "Center"), which is located to the actual rear of the property. The west property line is toward the residential properties, which border Alden Road to the south. The rear of the property, to the southeast, is to Colonial Plaza Shopping Center. The property consists of approximately 12,279 sf. The existing one-story building is 2053 sf +/-. The petitioner proposes to construct 2 one-story additions to the existing building: one is approximately 340 sf and would be to the northeast side of the building, toward Reisterstown Road and the Center; the second would be to the rear, the southeast, of the existing building, toward the shopping center, and would be approximately 247 sf. Both are more particularly described on the site plan accompanying this request for variances. Currently, the property has 7 parking spaces.

Section 409.6, BCZR, requires 5 parking spaces per 1000 sf of gross floor area. The total floor area with the additions would be 2,640 sf, thus requiring 14 parking spaces. The Petitioner requests a variance to permit the 7 parking spaces in lieu of the required 14.

In addition, as this is a corner lot, Colonial Road and Reisterstown Rd, the zoning office considers the northeast side yard of the addition to be a front yard. Section 302, BCZR, requires in the Bl zone, "...the front yard depth of any building shall be the average of the front yard depths of lots immediately adjoining on each side, providing the adjoining lots are improved with permanent commercial buildings..." The proposed addition will have a setback of 16' and the setback for the Center is 36', thus the average is 23'. The request is to permit a setback of 16' in lieu of the required 23'.

The property is unique due to its size and location. There is extremely limited area in which to add to the existing building, much less to provide additional parking. The only areas available for additions are those proposed by the Petitioner. Its uniqueness is underscored by the location of the existing building on the site, at an angle with its front toward Reisterstown Road, and its east side to both Reisterstown Road and to the Center.

There are no active Code Enforcement violation cases on this site.

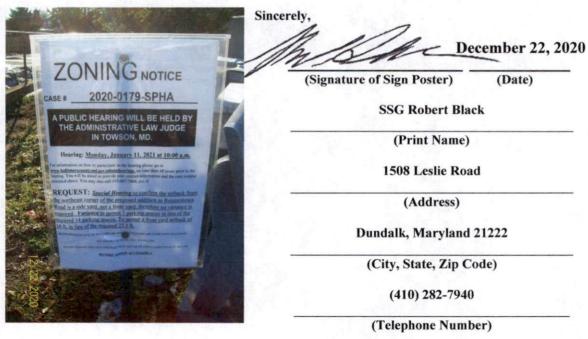

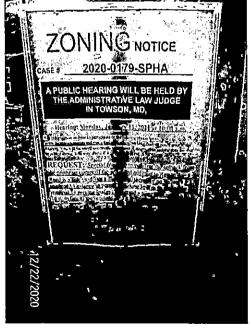

1. Special Hearing – To confirm the setback from the northeast corner of the proposed addition to Reisterstown Road is a side yard, not a front yard, therefore no variance is required.

2. Variance – To permit 7 parking spaces in lieu of the required 14 parking spaces; and to permit a front yard setback of 16' in lieu of the required 23'

A site visit was conducted on August 6, 2020. The property is located within the Pikesville Commercial Design Review Panel (DRP) area. The proposed additions may be subject to DRP review. The petitioner's representative should contact Ms. Jenifer Nugent, Chief of Development Review for DRP guidance.

The existing building is uniquely situated on a corner lot, making it difficult to expand and/or improve the property. 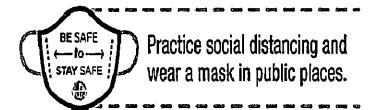

MOTION FOR RECONSIDERATION

Petitioner Zahrzeit Memorials, Inc., by and through Arnold E. Jablon and C. Andrew Robinson with Venable LLP, his attorneys, who submit this Motion for Reconsideration, as follows:

- 1. The Office of Administrative Hearings ("OAH") for Baltimore County issued an Opinion and Order on April 13, 2021 (the "Order") granting certain relief requested in a Petition for Variance and Special Hearing (the "Petition") filed by Petitioner, Yahrzeit Memorials, Inc. (see attached Exhibit 1).
- 2. Specifically, a variance was granted from Baltimore County Zoning Regulations ("BCZR") Section 409.6 to permit 7 parking spaces in lieu of the required 14 parking spaces.
- 3. The Order granted the relief subject to a condition that, "Petitioner must comply with the DOP comments, copies of which are attached hereto and make a part thereof" [sic] (see id., p. 4).
- 4. The Department of Planning comments dated September 2, 2020 (the "DOP Comment") states that the Department of Planning does not object to the requested relief, conditioned upon the following: (1) a landscape plan shall be approved prior to the issuance of building permits; (2) the existing dumpster shall be relocated; and (3) no temporary freestanding signs shall be permitted on the property. The DOP Comment also contemplated that the proposed addition "may be subject to DRP review" (see id., p. 6).
- 5. The DOP Comment was premised on a review of the site plan originally submitted in this case, Petitioner's Exhibit 1. However, due to negotiations with Ashville Partners, LLC ("Ashville"), the adjacent property owner, the proposed addition was relocated from Reisterstown Road to the interior of the property, as shown on Petitioner's Exhibit 9. The negotiations also included an agreement that the Petitioner would not plant any new landscaping higher than the top of the existing fence between the Petitioner's and Ashville's properties.
- 6. With the relocation of the addition, Petitioner believes the conditions in the DOP Comment are no longer appropriate.
- 7. There is no available space to relocate the dumpster or further landscape the subject property, and any significant landscaping on the property line between the Petitioner's property and Ashville's could breach the agreement described in Paragraph 5 above. The uniqueness of this

instant property mitigates against any additional landscaping. The property fronts, with its access from, Reisterstown Road, the adjacent residential properties are owned by the Petitioner and the Petitioner has entered into an agreement with its other neighbor, as described above. Any additional landscaping just will not survive the Reisterstown Road traffic.

- 8. The possibility of DRP review, as suggested in the DOP comments, is not contemplated in the clear language of the statute. The DRP was established by Section 32-4-203 of the Baltimore County Code, and that section lists the factors that trigger DRP review. The change in location of the proposed addition mitigates against the requirement of DRP review under Section 32-4-203.
- 9. The proposed addition was also reviewed by Kristin Zeminski, President of the Colonial Village Neighborhood Improvement Association, and Ms. Zeminski expressed the support of that association's board for the proposed addition as shown in Petitioner's Exhibit 11. The support of the local community association, as well as the fact that Petitioner is a small business operating on a unique lot further supports this motion. The property has minimal area to utilize and Petitioner has a need to expand the existing building for office use, but no where to do it without dramatically further limiting the use of the existing outside land area.
- 10. The rules of the Zoning Commissioner give the Administrative Law Judge broad authority to reconsider and reissue orders upon request within thirty days. In light of the relocated addition, the agreement between Petitioner and Ashville, community and neighbor support, and the uniqueness of the subject property, we request that you exercise that authority to replace the second condition of your order with the landscaping fence line agreement described in Paragraph 4 above.

WHEREFORE, Petitioner respectfully requests that the Office of Administrative Hearings for Baltimore County reconsider its April 13, 2021 Opinion and Order and revise the conditions therein.

OPINION AND ORDER

This matter comes before the Office of Administrative Hearings ("OAH") for consideration of Petitions for Special Hearing and Variance filed on behalf of Yahrzeit Memorials, Inc. ("Petitioner"). The Special Hearing was filed under § 500.7 of the Baltimore County Zoning Regulations ("BCZR") to approve the setback from the northeast corner of the proposed addition to Reisterstown Road is a side yard, not a front yard, therefore no Variance is required. A Petition for Variance was filed to permit 7 parking spaces in lieu of the required 14 parking spaces. To permit a front yard setback of 16 ft. in lieu of the required 25.3 ft.

Due to the COVID-19 pandemic, a public WebEx hearing was conducted virtually in lieu of an in-person hearing. The Petition was properly advertised and posted.

Substantive Zoning Advisory Committee ("ZAC") comments were received from the Department of Planning ("DOP"). They did not oppose the requested relief, subject to proposed conditions, which will be incorporated into the Order.

Petitioner Steve Venick appeared in support of the requested relief. Drew Robinson and Arnold Jablon, Esq. represented the Petitioner. Brian Dietz of Dietz Surveying, Co. the engineer who prepared and sealed the site plan also appeared. John Gontrum, Esq. appeared on behalf of Asheville Partners LLC, the owners of the adjacent Colonial Plaza Shopping Center. There were

no protestants or interested persons in attendance. However, Mr. Robinson submitted e-mail correspondence between Mr. Venick and Ms. Kristin Zeminski of the Colonial Village Pikeseville Community Association stating the association's support for the project. (Petitioner's Exhibit 11). Mr. Robinson also explained that after the original Petition was filed Mr. Gontrum entered his appearance and counsel requested a postponement of the hearing in order to attempt to negotiate a modification of the site plan. As a result of those negotiations the proposed office space addition was moved from the southeast corner of the lot to the northwest corner. The redlined site plan was admitted as Petitioner's Exhibit 9. Mr. Robinson further explained that based on this modification the petitioner no longer needs the special hearing or front yard setback relief. As a result, the only remaining relief sought at the hearing was the variance from BCZR Sec. 409.6 to allow 7 parking spaces in lieu of the required 14 spaces. Mr. Gontrum confirmed the accuracy of Mr. Robinson's proffer.

Variance

A variance request involves a two-step process, summarized as follows:

- (1) It must be shown the property is unique in a manner which makes it unlike surrounding properties, and that uniqueness or peculiarity must necessitate variance relief; and
- (2) If variance relief is denied, Petitioner will experience a practical difficulty or hardship.

Cromwell v. Ward, 102 Md. App. 691 (1995).

As Mr. Robinson explained, the property is unique in several respects. It is approximately a third of an acre. It is an irregular triangular shape and is bordered by two public roads. The existing structure is a former gas station that is set in the far back of the site. The two access points on Reisterstown road eat up much of the potential area for parking spaces. Mr. Venick testified that his family has operated Fram Monuments at this location for over 40 years. He explained that

it is not a typical retail business in that most of their business is conducted on-line or over the phone. There are few "walk in" customers so the 7 existing parking spaces have proven to be more than adequate. He further explained that the proposed addition will simply expand the office space for the business and should not generate any additional need for parking. Finally, Mr. Venick noted that he owns the adjoining properties on Colonial Road that will back to the proposed office addition.

I therefore find that the subject property is unique and that if the parking variance is denied the petitioner would suffer practical difficulty and hardship because they would be unable to construct the office space they need. I further find that the variance relief is within the spirit and intent of the BCZR and that it will not harm the public health, safety, and welfare. This finding is buttressed by the lack of community opposition or any county agency opposition.

THEREFORE, IT IS ORDERED this 13th day of April 2021, by this Administrative Law Judge, that the Petition for Special Hearing under BCZR § 500.7 to confirm that the setback from the northeast corner of the proposed addition to Reisterstown Road is a side yard, not a front yard, and that therefore no Variance is required be and is hereby DISMISSED WITHOUT PREJUDICE, as MOOT; and,

IT IS FURTHER ORDERED that the variance to permit a front yard setback of 16 ft. in lieu of the required 23 ft. is hereby DISMISSED WITHOUT PREJUDICE, as MOOT; and,

IT IS FURTHER ORDERED that the variance from BCZR § 409.6 to permit 7 parking spaces in lieu of the required 14 parking spaces is hereby GRANTED.

The relief granted herein shall be subject to the following:

 Petitioner may apply for necessary permits and/or licenses upon receipt of this Order. However, Petitioner is hereby made aware that proceeding at this time is at their own risk until 30 days from the date hereof, during which time an appeal can be filed by any party. If for whatever reason this Order is reversed, Petitioner would be required to return the subject property to its original condition.

• Petitioner must comply with the DOP comments, copies of which are attached hereto and make a part thereof.

Any appeal of this decision must be made within thirty (30) days of the date of this Order.

The Department of Planning has reviewed the petition for the following:

1. Special Hearing - To confirm the setback from the northeast corner of the proposed addition to Reisterstown Road is a side yard, not a front yard, therefore no variance is required.

2. Variance - To permit 7 parking spaces in lieu of the required 14 parking spaces; and to permit a front yard setback of 16' in lieu of the required 23'

A site visit was conducted on August 6, 2020. The property is located within the Pikesville Commercial Design Review Panel (DRP) area. The proposed additions may be subject to DRP review. The petitioner's representative should contact Ms. Jenifer Nugent, Chief of Development Review for DRP guidance.

This response refers to your January 4, 2022 letter to Mr. Jeffery Perlow, Chief of Zoning. You requested in your letter, to have building permit C21-01097 approved under Zoning Case # 2020-0179-SPHA. The amended order dated April 26, 2021, granted 7 parking spaces in lieu of the required 14. Also, dismissed without prejudice, a front yard setback of 16 ft in lieu of 23 ft and confirm the side setback from the northeast corner of the proposed addition with Reisterstown Rd is the side yard and not a front yard, therefore, not needing a Variance.

Please be advised that the documents and your request have been reviewed. Based on the final order, Colonial Rd is the front yard. The request to approve the building permit can only be completed if the front setback is shown on the site plan from the front of the proposed addition to the closest point of the property line on Colonial Rd. The required 10 ft side setback is already met by the noted 12 ft setback on the plan. Once the front setback is shown on the plan and determined to be 25 ft or less, the permit can be approved.

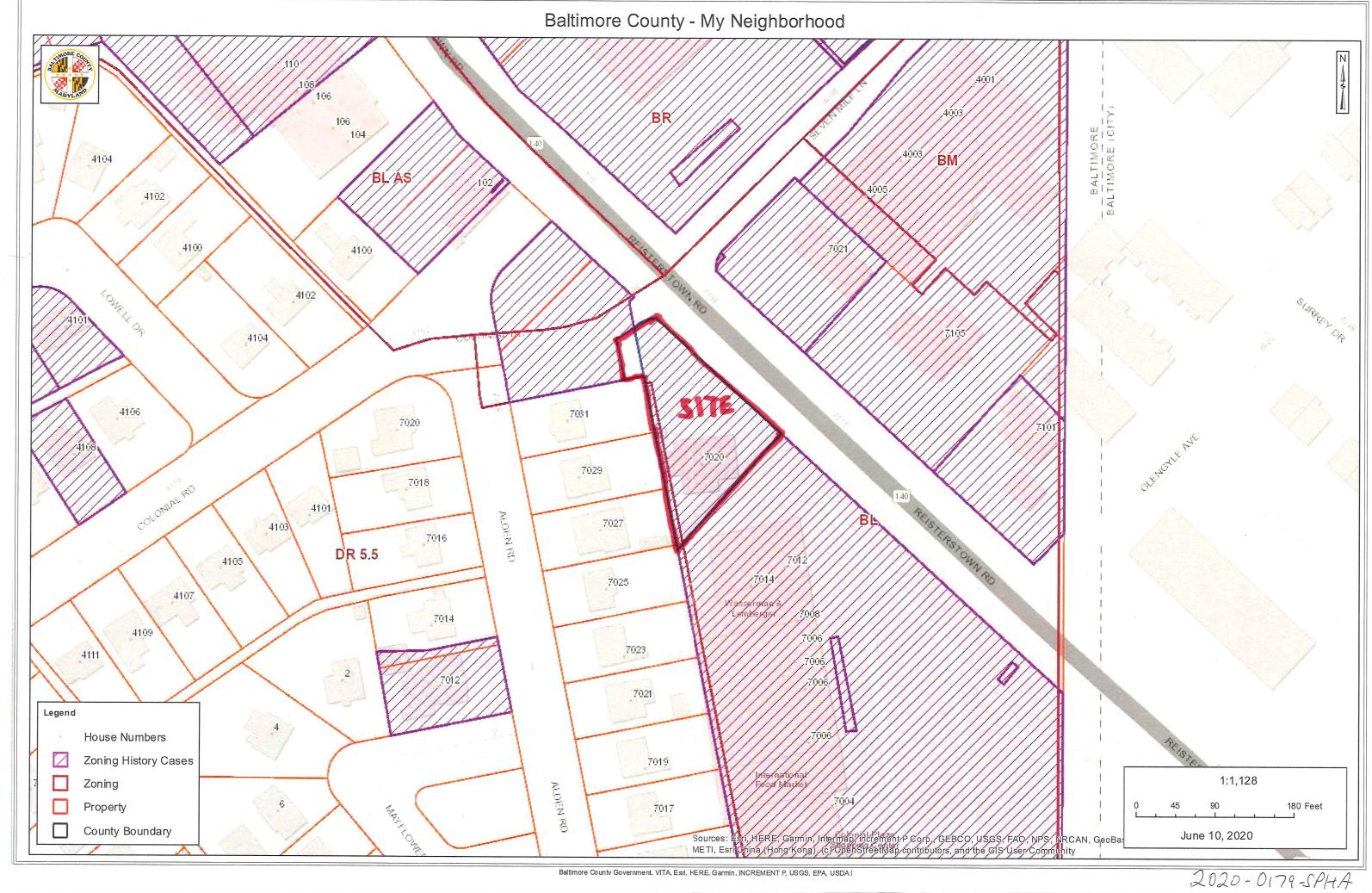
I checked with the board and they are completely fine with the project. Good luck on your extra office space! We really appreciate that you brought that to our attention.
