DSM, Nichols and PC Builds all questioned the playground equipment foundation details. The foundations should be left out of the contract and placed under the county's playground contract. We will keep the underdrains in this contract.

DSM Contracting

- Please provide playground equipment foundation details as noted on Sheet C-109. Nick

 County needs to provide. The foundation should be left out of the contract and placed under the county's playground contract. We will keep the underdrain in this contract.
- We would like to request that the CAD drawing files be made available to assist in our quantity takeoff efforts. Nick – Does the county do this for their projects? No CAD files at this time.
- 3. The existing contour lines on Existing Conditions Plan 1 (Sheet C-101) do not align with the existing contour lines shown on Proposed Grading Plan 1 (Sheet C-109). Please advise which plan has the correct alignment and shall be used for bidding purposes. Contours are the same. If inconsistencies are seen, please be more specific as to location.

We need a few questions answered to confirm we are giving them what they want.

- 1. Please confirm they want the 40' Lam Beams PT (Pressure treated) as they are not typically, since they don't get wet. PT is required
- 2. What is roof pitch on gazebo? To be determined by the manufacturer based upon the model and dimensions indicated on the plan details
- 3. Is space between clerestory closed (as shown on bid drawing) or open air? Closed
- 4. Is metal roofing exposed fastener metal or true standing seam hidden fastener metal? (True standing seam 2x as expensive) The pavilions are pre-engineered. See "PRE-ENGINEERED METAL PAVILION GENERAL SHEET NOTES" on Drawing Number 2022-2290, "BASIS OF DESIGN: MANUFACTURER: ICON SHELTER SYSTEMS, INC., MODEL NUMBER OC40011S2C-P4." The pre-engineered pavilion manufacturer will dictate what roofing system and components will be used.

- 6. What is 18" "Carousel Style" fascia panel? Reference the manufacturer's standard details

- Question 3) Is the project schedule per section 013216 intended to be a bar chart schedule or a Critical Path Method (CPM) Schedule? If the schedule is to be a bar chart, what are the monthly updating expectations? Critical Path Method (CPM) Schedule Nick County needs to confirm. Monthly progress reporting via virtual or on-site meeting with 2 weeks look ahead provided each meeting.
- Question 4) Will the contractor be required to provide fencing around the entire construction site to comply with the entry control requirements stated in section 013553? No
- Question 5) Will the contractor be permitted to use the onsite water that serves the existing comfort station? Nick County needs to provide direction. No, please use water trunk
- Question 6) Will the contractor be permitted to use the existing comfort station of will we be required to provide temporary toilets? Yes Nick County needs to provide direction. Contractor must use temporary toilets.
- Question 7) Is the contractor responsible for any soil removal and/or replacement, below new work subgrade, if unsatisfactory soil is encountered. Yes
- Question 8) Please provide details or a quantity of playground equipment foundations that are to be provided per sheet C-106. Nick County needs to provide. The foundation should be left out of the contract and
